SPECIAL MEETING AGENDA

At the request of Chair Marvin Jackson, Wayne Tippett led the meeting. It was called to order at 1:01 p.m. and began with the Pledge of Allegiance. A quorum was present.

SELECTION PROCESS: The first item of business was to review District 1 selection criteria and process. The Commissioners made no modifications to published information or draft questions and the rating sheet.

Information was shared regarding the length of the term for District 1. Since we had missed the primary for 2018, the next election cycle begins with registration in May 2019 with service beginning officially on January 1, 2020. The term of the applicant selected, therefore, would run from now through December 31, 2019.

Belinda and Monika were asked by the Commissioners if they wished to express an opinion regarding the best candidate. They acknowledged that all candidates had strengths and that the decision would be difficult.

EXECUTIVE SESSION: At 2:14 p.m., the Commissioners then went into Executive Session for 10 minutes so that Commissioners Jackson and Tippett could compare rating sheets and discuss the selection of the Commissioner for District 1.

EXECUTIVE SESSION WRAP-UP: At 2:24 p.m. the Commissioners came out of Executive Session. Commissioners Jackson/Tippett made a motion to select Mark Brigham as the District 1 Commissioner for the Port of Clarkston. Motion carried.

Commissioners Tippett/Jackson made a motion to close the application process. Motion carried.
